**Sub:** **Applicability and validity of OBC (Non-Creamy Layer) certificates for admission and document verification process for academic session 2026-27.**

Sir,

With reference to the subject mentioned above, I am herewith sharing the directive issued by the DoPT, Government of India vide O.M. No. 36036/2/2013-Estt. (Res-I) dated 31.03.2016 regarding the validity period of OBC certificates in respect of Creamy Layer status of candidates and Memorandum No. 1204-SBCW/MR-67/10 dated 27.07.2015 issued by this Department governing the issuance and validity of OBC (Non-Creamy Layer) certificates (copies enclosed).

In terms of the aforesaid guidelines, this Department is of the considered view that the community status of candidates possessing an old OBC Certificate and belonging to any of the 66 classes included in the State List of OBCs vide Notification No. 945-BCW/MR-33/2026 dated 18.05.2026 remains permanent and unchanged. However, the Non-Creamy Layer status, being dependent on the economic and service status of the parents of the certificate holder, is subject to periodic determination and remains valid only for the relevant financial year for which the certificate is issued.

Accordingly, every candidate seeking reservation benefits under the OBC category shall produce a valid OBC (Non-Creamy Layer) certificate applicable for the financial year in which the prescribed crucial date or cut-off date set by the admission authority falls, as the eligibility of the candidates for admission and document verification purposes shall be determined with reference to the said date.


